Duties and Expectations

General Responsibilities:

- Acting as a fiduciary (trustee) of the organizations financial and business affairs (holding and administering property in trust); asking questions, understanding everything
- 2. Determining the organizations policies, seeing that they are carried out
- 3. Hiring and supervising personnel
- 4. Performing all other duties required by law, Articles of Incorporation and bylaws

Minimum Position Requirements:

- 1. Interest in and support for The Arc of Butte County and its goals and objectives
- 2. Specific experience and expertise in areas of Board operation. Preferred areas of expertise include, but are not limited to: administration, evaluation, finance, fundraising, health and safety, local government, media, personnel, program development, public relations and more.
- 3. Willingness to attend all Board meetings, which shall be held in person (with the option of Zoom when safety requires), serve on at least one Board committee and participate in appropriate organization activities and events.
- 4. Willingness to participate in Board orientation and training activities and to fulfill Board duties and responsibilities.

Specific Duties and Responsibilities:

- 1. <u>Policy</u>: Make policy in key areas, including Board procedures and operation, financial controls, personnel procedures, public relations and fundraising activities. Responsible for ensuring The Arc operates within its adopted bylaws and acts on proposed revisions to bylaws. Recommends policies, which determine the purpose, governing principles, functions and activities of The Arc.
- 2. <u>Legal/Finance</u>: Regularly monitors implementation of policies along with all aspects of The Arc, including committee work, proposals and company operation. Ensures The Arc is properly managed, that reasonable judgement is used in all business and financial transactions and proper government procedures are followed. Approves and monitors the organizations finances. Authorizes and approve the annual audit. Responsible for recommending and monitoring all organization expenditures dealing with the organization and its operation.
- 3. <u>Planning</u>: Approves The Arc's mission and its parameters. Approves goals, objectives and direction of The Arc.
- 4. Program Evaluation: Monitors and strengthens Arc programs and services.
- 5. <u>Personnel</u>: Recruits, hires and evaluates Executive Director. Reviews and approves personnel policies. Participates in recruitment and development of Board and committee members.
- 6. <u>Fundraising</u>: Creates the financial climate for fulfilling The Arc's purposes through fundraising activities. Approves fundraising goals and plans. Participates in fundraising activities and efforts.

- 7. <u>Public Relations</u>: Represents The Arc to the public. Commits to enhancing The Arc's public standing.
- 8. <u>Board Governance</u>: Recruits new Board and committee members, according to bylaws and other priorities. Assesses Board performance.
